## HIGHLAND DANCING RULES

- The competition will be conducted following S.O.B.H.D. rules. The judge's decision is final.
- The first dancers to enter shall be last to dance.
- Dancers must be in costume to accept awards.
- Competitors not ready when their event is called will be disqualified for that dance.
- The number of entries will determine age groupings.
- Dancers must present 2009, valid registration card.
- A trophy will be awarded to the highest point winner in each age group. No trophy will be awarded to the primary level. Medals will be awarded at the judge's discretion.
- **Cash awards for premiers:**
  - **Group 1 – \$40, \$20, \$10**
  - **Group 2 – \$50, \$30, \$20**
  - **Group 3 – \$60, \$40, \$30**
  - **Premier Award**
- **Dancer of the Day Award - \$50**
